OLD BUSINESS:

Executive Committeeman Scheuer asked if a letter was sent to Past Secretary Finnegan on the at the decision last meeting of Executive Committee regarding his request. President Ordway said no, but when he received the e-mail from Past Secretary Finnegan he responded and apologized. He said he would take the blame for the confusion as to who should have sent the letter.

A motion was made by Executive Committeeman Kelly and Seconded by Executive Committeeman Scheuer to go into Executive Session at 9:24am. Motion Passed

A motion was made by Executive Committeeman Naylis seconded by Committeeman Scheuer to return to Regular Session at 10:04am. Motion Passed

NEW BUSINESS:

- 1) A motion was made by Executive Committeeman Naylis, Seconded by Executive Committeeman Lane to remove Robert Daunbenberger from membership in the New Jersey State Firemen's Association and forfeit any and all benefits provided.
- On a Roll Call Vote Passed 21-0
- 2) A motion was made by Executive Committeeman Spiegel seconded by Executive Committeeman Florio to place Andover Boro under review for 3 years due to the overpayment of Supplemental Relief and to ask Andover Boro if there is any way the overpayment can be returned. On a Roll Call Vote Passed 21-0
- 3) A motion by Executive Committeeman Fazekas, seconded by Executive Committeeman Scheuer to allow the President and Vice President to attend the New Jersey State League of Municipalities Conference in Atlantic City and the Congressional Fire Services Institute Dinner in Washington, DC. On a Roll Call Vote Passed 21-0
- 4) Treasurer Osborn stated that since we have been in the new building with 4 new Secretaries (which is now at 3) and one remaining, the Officers feel that the staff worked seamlessly with one fewer secretary and that they did an exceptional job. He stated that the Officers would like to give the secretaries a \$2,000 increase in their salary. A motion was made by Executive Committeeman Mellert, seconded by Committeeman Lane to give the secretaries a \$2000.00 increase in their salary beginning October 1. On a Roll Call Vote Passed 21-0

GOOD OF THE ORDER

- 1) President Ordway mentioned that the Tram Cars will not be running south of the Convention Center. He stated that extra golf carts will be available to shuttle people to the Convention Center from the south end of the Boardwalk.
- 2) Executive Committeewoman Badger asked what the Age Survey sent to all locals was about. President Ordway explained that this is what one of the members of the Executive Committee requested after receiving several letters from member and Associations. He stated that approximately 250 were received but some of them contained wrong numbers. Those were surveys that included current members. He stated that we are reaching out to those Associations to get corrected numbers. He said once all of the surveys have been received that they will be given to the Compendium and Long Range Planning Committees to review and then report to the Executive Committee and action if needed will be taken. He also stated that any change to the ages will be a change to State Statue and will require Legislative approval.
- 3) Executive Committeeman Otterbein asked what is the procedure to respond to the letter from the Secaucus Firemen's Relief Association regarding "need" for Relief. President Ordway stated that it will go to the Advisory Committee and they will report back to the Executive Committee their recommendation, if any. Then a response to the Secaucus Relief Association will be sent to them.

ADJOURNMENT: On a motion by Executive Committeeman Otterbein, seconded by Executive Committeeman Florio the meeting was adjourned at 10:20am.

Report to the 142nd Convention of the New Jersey State Firemen's Association John V. Lane, Chairman of the Compendium Committee

The Resolution of the Gloucester Township Fireman's Relief Association approved at the 2018 Convention requested that the Executive Committee investigate and report back to the Convention as to whether or not Life Members should be allowed to make motions and vote at Local Relief Association meetings.

Presently the New Jersey State Firemen's Association By-laws state that only Representatives may make or second motions and vote on any matters brought before the local association meeting.

A Life Member is simply a designation or name for someone who has attended ten session of the State Convention and has no bearing on their role in the Local Relief Association. Any member of a Relief Association, including those with the Convention Life Member title, can be selected as a Representative and/or can hold title as a Relief Association Officer or Trustee. Being a State Convention Life Member does not prevent a person from participating in the activities of the Local Relief Association—just as any other Local Relief Association member has the right of participation.

Associations that are having trouble with attaining quorum at meetings should replace the Representatives that are not showing up with individuals that are willing to show up and that includes replacing them with individuals that have the designation of being a Convention Life Member.

The Compendium Committee was advised by our attorney on the role of the Board of Representatives in conducting the business of the Local Relief Association. There are four statutes that make reported references to the fact that it is the Board of Representatives that conducts the official business of the local Relief Association. There are no references therein to Life Members, Delegates or other members of the Local Relief Association being authorized to make or second motions or vote on local association business.

The Committee discussions were extensive as to both the pros and cons of seeking a change in our statues. At the conclusion of those discussions, it was decided that the Association should not seek to change the statutes. The full Executive Committee agreed with this determination at the February 23, 2019 meeting.

To: Officers & All Members of the Executive Committee,

There was one of our bills that were signed into Law since the last Executive Committee Meeting in July. Bill S1799 – Increases membership of fire safety commission in DCA by four members was signed into Law on 07/19/2019.

Since the last Executive Committee Meeting there were no new bills added into our tracked lists. The total numbers of tracked bills are 250, with 166 from Fire & Emergency Services, 32 from Fire Districts, and 52 from Pensions. Total bills that were introduced for the 218th Legislative Session (2018-2019) are, 10,841. The current Legislative Session ends on January 14, 2020. There are some scheduled sessions for the rest of this month as they are just returning from last months' vacation.

Under Federal Legislation, Trump signed a 9/11 Bill for permanent funding, "Never forget the Heroes" bill was signed on July 29, 2019 by President Trump.
